

## Racial Justice Opera Network Steering Committee Member Duties

The Racial Justice Opera Network Steering Committee is composed of dedicated volunteers who are trusted with guiding the racial justice commitment of OPERA America, which leads and serves the entire opera community, supporting the creation, presentation, and enjoyment of opera.

## **Purpose of Racial Justice Opera Network**

OPERA America's Racial Justice Opera Network is an action group of opera professionals from all sectors of the field who are committed to enriching our art form and industry by seeking racial equity.

The Racial Justice Opera Network is a coalition of BIPOC and White antiracist members working to dismantle racism in opera by actively changing policies and practices that perpetuate the oppression of Black people, Indigenous people, and other people of color.

The Steering Committee is seeking members with skillsets, interests, and experiences that contribute to the operatic art form. Applicants are not required to have a career in opera.

**Skills/Experiences:** Individuals who wish to make a meaningful contribution to the steering committee will:

- Identify as Black, Indigenous/First Nation/Native American, Asian, Pacific Islander, Latiné, and/or groups within the identity of a person of color, including multiracial identity.
- Have a desire to champion the diversity and collaborative nature of opera.
- Have a personal commitment to abolishing racism and racial injustice.
- Have demonstrated knowledge and skill (of any scale) in guiding racial justice initiatives in collaboration with others.
- Align with OPERA America's commitment to racial justice and racial equity.
- Dedicate time to guide, assess, and implement racial justice initiatives.
- Co-create affirming spaces for discussion, learning, and implementation for all identities.

**Commitment:** Steering committee members are expected to contribute dedicated time and knowledge to ensure the successful progress of racial justice in the opera field. Average time commitment is three to four hours a month through:

• Two-year terms with an opportunity to extend to an additional third year

- Monthly RJON Steering Committee meetings (90 minutes)
- Working groups for specific projects, including research, meetings, and written/verbal communication
- Drafting, reviewing, and/or editing communication to the opera field
- Field engagement through network meetings and annual forum

**Process:** Current committee members will review applications with a focus on fulfilling the needs of the committee's collective skillset. Prospective members will be contacted no later than January 15, 2024, to schedule an interview/discussion. New steering committee members will be announced as confirmed.
